#### HISTORY OF PRESENT ILLNESS: (HPI on admission read off what HPI says)

This is a 43y/o male who presents to DRMC on 10/29/15 with the complaint of left sided abdominal pain with nausea. Patient stated that the pain started approximately x3 days ago. It has been constant and is rated at approximately 8/10 in intensity. Patient describes pain as sharp,stabbing, and mainly in the LLQ. The patient states the pain was unbearable. Therefore he went to the ED for further evaluation and treatment. Patient also had subjective fever and chills, however, denies night sweats. Patient had a similar attack several years ago and was diagnosed with diverticulitis....
